## 7.0 Learning Outcomes

The Recreation, Sports, and Park Administration Program has tremendous community based recreation and sports resources and agencies in Springfield and the surrounding areas. The RSPA faculty takes full advantage of those resources to give students the broadest exposure to the professional field, by connecting them to their classroom experience. In the courses identified in Standard 7.01, students hear from practitioners and area alumni as guest speakers or by taking agency field trips to link the classroom experience and professional opportunities in the field. This is accomplished through written assignments, exams, projects and a practicum experience giving many students their initial, first hands-on experience in the field.

In Standard 7.02, students in REC 205 and REC 390 apply classroom content to real practice through Service Learning assignments with a community recreation partner, which includes written assignments for learning outcomes.

Standard 7.03 includes the senior level capstone courses that requires students to complete comprehensive projects and assignments that will enable them to apply all the knowledge and skills they have acquired in their RSPA curriculum. There are two comprehensive projects in REC 422 and REC 423, as well as a community research project conducted by students for a local recreation agency in REC 330.

The Springfield-Greene County Park Board just celebrated their 100<sup>th</sup> anniversary by spotlighting their 100 parks. Springfield is also the national headquarters for Bass Pro Shops, the number one tourist attraction in the state of Missouri, which is nationally recognized by the Missouri Department of Conservation. Additionally, Springfield has nearby state parks; the Corp of Engineers; the Federal Bureau of Prisons; a nationally recognized trail system; the Community Olympic Development Programs for youth including archery, hockey, volleyball, and wrestling; a minor league team for the St. Louis Cardinals; and the only city to be designated by Sports Illustrated as the, "50th Anniversary Sportstown" for the State of Missouri. These are just a few of the highlighted areas our students have had the opportunity to either volunteer or work part-time and/or seasonally in the field.

REC 152 Introduction to Recreation, Sport and Park Administration  It must be noted that as with any 100 level course, a portion of the class that enrolls in Introduction to Recreation, Sport, and Park Administration as an elective course skews the class assessment result, reflecting scores of non-majors that likely do not value the foundational and philosophical context of the course to be significant to them as a learning experience. In future semester's faculty will track which students become majors and re-evaluate their scores for future reporting. Additionally course assessment will be made using single chapter quizzes to more specifically assess foundational content in addition to the comprehensive final and will provide a final review guide for future semesters.
REC 211/311 Principles of Outdoor Rec / Outdoor/Adventure Education Additionally, REC 211 Principle of Outdoor Recreation / REC 311 Outdoor/Adventure Education are listed together because all students are only required to take one of these courses. However, Parks and Outdoor Recreation emphasis requires both for students. The same outcomes are mutually measured for the courses to post data for only those students required to take one of the two.

1) Statistics/Math has been one of the weakest areas for many RSPA students. Additional homework/exercises and tutoring will be offered to improve students' performances on quizzes and final exam. It must be noted that the final exam is approximately 10% of the overall grade of this class and some students choose not to participate in the final exam, which may also play a factor in meeting the 70% pass rate by all students.

1) Students were given additional opportunities to revise various sections of the project to make improvement, which appeared to help students' overall performances. Such practices will be continued in this class.

1) Fall 2013 was the first semester a new textbook was used, which could explain part of the struggle some students exhibited in their performance with the chapter quizzes. In Fall 2014, more time was spent focusing on key legal terms during class discussions and

that technique appeared to assist students in performing much better in quizzes.

1) There does not seem to be a need to make any significant changes in the delivery of this course based on the current student outcomes data.

1) Grant writing was added because students had little to no experience in that area. More emphasis has been placed on technology in the workplace, based on input from our alumni and our partners in the field; IPads and Dropbox are being utilized in teaching methods. Students understand this technology, but typically more for social uses versus business applications. Additional, emphasis is being placed on budgeting because it appears to be a weakness in student learning and has been included in feedback as a need from Ad Hoc committee.
